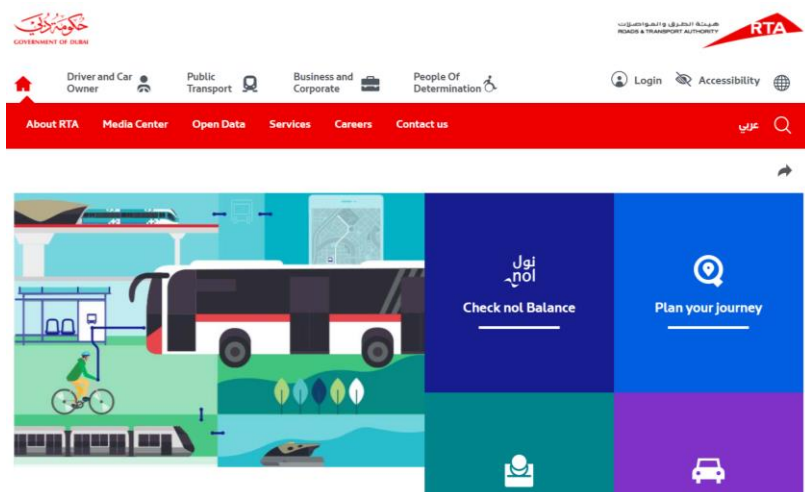

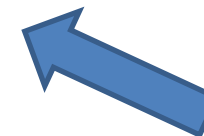

- Username guidelines:**
- Must be at least 6 characters.
- It can contain letters [A, B, C], numbers [1, 2, 3], and Periods [.]
- Special characters are not allowed [&, \*, %, \$, #, @]



**Finish Registration**
