

Bicycle-Friendly City

Dubai is making headway strides realising the vision of His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice-President, Prime Minister of the UAE, Ruler of Dubai, to make Dubai the best city for living in the world by improving the quality of living in the city and putting people's happiness first. Such a drive seeks to implement the directives of His Highness Sheikh Hamdan bin Mohammed bin Rashid Al Maktoum, Crown Prince of Dubai, Chairman of the Executive Council, to transform Dubai into a Bicycle-Friendly City. Achieving this goal warrants the development of a world-class infrastructure tailored to support the use of this sustainable mode of mobility in compliance with the highest safety and security conditions.

His Highness the Crown Prince of Dubai has recently directed to execute a 16-km long cycling track alongside Jumeirah Beach that connects with the existing cycling track of Jumeirah Street running alongside the Dubai Water Canal, and the existing cycling track on King Salman bin Abdul Aziz Al Saud Street at the Dubai Internet City.

The first section of the track, which is 4 metres wide, runs alongside Jumeirah Beach in parallel to the existing jogging and walking tracks at the beach extending from Dubai Water Canal up to Umm Sugeim Park. The second section that has a width of 3 metres, runs alongside Jumeirah Street and

King Salman bin Abdul Aziz Al Saud Street up to the Dubai Internet City.

The new cycling track runs along several key landmarks alongside Jumeirah Beach such as the Sunset Mall, Open Beach, Dubai Sailing Club, Kite Beach, Umm Sugeim Park and Burj Al Arab. It will enable cyclists to cycle along the stretch of the beach and make use of the bike sharing services available at the Sunset Mall, Al Manara Mosque and Umm Sugeim Park.

The Master Plan for Cycling Tracks in Dubai, approved by His Highness Sheikh Hamdan bin Mohammed bin Rashid Al Maktoum, includes the construction of an additional 276 kms of cycling tracks, which will bring the total length of cycling tracks in the Emirate to 739 km. The plan aims to link the tracks at the central and coastal areas, such as Jumeirah, Al Sufouh and Dubai Marina with the peripheral and leisurely tracks at Al Oudra, Seih Assalam and Nad Al Sheba via Al Barsha. Dubai Hills and Nad Al Sheba.

In designing and executing cycling tracks and regulating the speed limits thereon, RTA is keen to comply with the top international standards and technical directories and customise them to fit the nature of the location and the classification of tracks. It also seeks to encourage residents and visitors to practice cycling as a healthy sport, but also to use bikes as an alternative and sustainable means of mobility, especially to serve first and last-mile journeys.

"The construction of this cycling track is a manifestation of the vision of His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice-President, Prime Minister of the UAE, Ruler of Dubai, to improve the quality of life for people in Dubai and make them happier.

It is also a step forward towards achieving sustainable mobility," said His Excellency Mattar Mohammed

Al Tayer, Director-General, Chairman of the Board of Executive Directors of the Roads and Transport Authority (RTA).

"It also responds to the directives of His Highness Sheikh Hamdan bin Mohammed bin Rashid Al Maktoum, Crown Prince of Dubai, Chairman of the Executive Council, to transform Dubai into a bicycle-friendly



city. It involves the provision of suitable alternatives to encourage people to practice cycling. It contributes to Dubai Urban Plan 2040, which aims at raking Dubai as the best city in the world for living. Constructing this cycling track alongside Jumeirah Beach is a quality addition to the infrastructure projects undertaken by Dubai Government to promote sports and recreational activities and uplift the standard of living and wellbeing in the Emirate," added Al Tayer.

Integrated Services

Detailing the integrated services of the project, Al Tayer said, "The new cycling track stretches 16 km alongside Jumeirah Beach and links the existing cycling track at Jumeirah Street (at Dubai Water Canal) with the existing cycling track at King Salman bin Abdul Aziz Al Saud Street (at Dubai Internet City). "The first sector of the track has a width of 4 metres stretching alongside Jumeirah Beach in parallel to the existing jogging and walking tracks that extend from Dubai Water Canal up to







Umm Sugeim Park. The second sector, which has a width of 3 metres, runs alongside Jumeirah Street and King Salman bin Abdul Aziz Al Saud Street up to Dubai Internet City. It will serve several hotspots alongside Jumeirah Beach such as the Sunset Mall, Open Beach, Dubai Sailing Club, Kite Beach, Umm Sugeim Park, and Burj Al Arab.

"The public can use the track in practising cycling alongside a beach that boasts of a variety of service facilities. They can also benefit from the shared bike services available at the Sunset Mall, Al Manara Mosque and Umm Sugeim Park. The speed limit set for this track is 20 km/h and is classified as part of the mobility, sports and leisure tracks," commented Al Tayer.

"The cycling track of Jumeirah Beach is part of a master plan for constructing cycling tracks to link vital areas of the Emirate. The Master Plan for Cycling Tracks 2026 provides for the construction of additional cycling tracks extending 276 km, which will bring the total length of cycling tracks in the Emirate to 739 km. The plan aims to link the tracks at the coastal areas, such as Jumeirah, Al Sufouh and Al Marina with the external tracks at Al Oudra, Seih Assalam and Nad Al Sheba via Al Barsha, Dubai Hills and Nad Al Sheba," explained Al Tayer.

International Specifications

"The design, construction and setting of speed limits for cycling tracks are in line with the top international standards and technical directories. It is also customised to the nature of the locality and the classification of the tracks. These tracks encourage residents and visitors to practice cycling such that it will develop into an alternative and sustainable mobility means that serves the first and last-mile strategy." concluded Al Taver. It is noteworthy that the dedicated cycling tracks constructed till the end of 2020 extended 463 km. RTA intends to push the total length of cycling tracks further to 739 km by 2026 to link vital areas of the Emirate with various public transit means.

Cycling Speed

RTA has set a speed limit of 30 km/h at cycling tracks dedicated to cyclists and a speed limit of 20 km/h at dedicated or shared tracks with pedestrians within urban areas. However, no specific speed limits are set for cycling tracks for training purposes. The overall objective of introducing speed limits for cycling tracks is to ensure the safety of both pedestrians and cyclists.





Hamdan bin Mohammed forms Supreme Committee for Urban Planning in Dubai

Dubai Crown Prince and Chairman of The Executive Council of Dubai His Highness Sheikh Hamdan bin Mohammed bin Rashid Al Maktoum has issued the Council's Resolution No. (18) for 2021 forming the Supreme Committee for Urban Planning in Dubai. The Resolution aims to regulate and ensure the governance of urban planning in Dubai as well as implement the deliverables of the Dubai 2040 Urban Master Plan, endorsed by His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice President and Prime Minister of the UAE and Ruler of Dubai, in March this year.

The Committee has been entrusted with the oversight of the urban planning sector in the emirate, including the implementation of the Dubai Urban Master Plan. The Committee will ensure the plans of related government entities in the emirate are aligned with the Dubai 2040

Urban Master Plan and ensure the integration of major infrastructure and urban projects as part of realising the vision of HH Sheikh Mohammed to make Dubai the best city in the world to live in.

Under the Resolution 'The Supreme Committee for Urban

Committee to govern urban planning in Dubai and implement the deliverables of the Dubai 2040 Urban Master Plan - Committee will facilitate efforts to realise the vision of Mohammed bin Rashid to make Dubai the best city in the world to live in

Planning' will be formed under the chairmanship of His Excellency Mattar Mohammed Al Tayer, the General Commissioner of the Infrastructure, Urban Planning and Wellbeing Pillar.

Members of the Committee include the Managing Director and CEO of Dubai Electricity and Water Authority; the Director General of Dubai Municipality; the Director General of Dubai Development Authority; the Director General of Ports, Customs & Free Zone Corporation; the Director General of Dubai Land Department; the CEO of RTA's Strategy and Corporate Governance and the Secretary-General of the Supreme Council of Energy. Other members, will include an urban planning expert and economic expert to be named by the Chairman of the Committee.

The Resolution details the roles and responsibilities of the Committee, which include endorsing the vision and strategic objectives of the Urban Master Plan, under the supervision of the Chairman of The Executive Council and ensuring that the Urban Master Plan progresses according to deliverables and in line with government priorities and directives. The Committee is also responsible for ensuring the integration of the roles of the entities responsible for urban planning in the emirate and directing the provision of support to facilitate coordination between various parties.

The Committee will also resolve any issues or differences between concerned bodies in case the parties fail to reach an agreement. It will report such issues to The Executive Council when required. According to the Resolution, the Committee will propose policies, strategies and legislation to ensure the objectives of the Urban Master Plan are met, as well as empower concerned bodies in the emirate to carry out their respective tasks and roles.

The Supreme Committee for Urban Planning will also be responsible for endorsing the recommendations made in strategic studies, masterplans and major infrastructure and urban projects related to urban planning in conformity with the Dubai 2040 Urban Master Plan and informing the Chairman of The Executive Council about them. It will also issue directives for carrying out major changes to the approved Urban Master Plan, in line with the developments and directives of the Dubai Government in this regard.

Under the Resolution, the Committee is responsible for



reviewing the strategic performance indicators for the implementation of the Urban Master Plan. It will also direct measures and solutions to enhance the efficiency of implementation. The Committee is also authorised to issue directives with regards to challenges encountered in the implementation of all phases of the Plan.

The Resolution permits the Committee to form sub-committees and teams to assist it along with their roles, responsibilities, procedures and any other related issues. The Committee may seek the assistance of any experts and specialists, be it from employees of the concerned bodies in the emirate or others.

Administrative and Technical Support

The Resolution tasks the Dubai Municipality to deliver administrative and technical support to the Committee to enable it to carry out its duties as per the Resolution.

Full Cooperation

The Resolution mandates all relevant government bodies in the emirate to fully cooperate with the Committee, Sub-Committees and teams and provide all information, statistics and documents required to carry out the tasks of the Committee under this Resolution.

Strategic Files

His Excellency Mattar Mohammed Al Tayer, the General Commissioner of the Infrastructure, Urban Planning and Wellbeing Pillar and Chairman of the Supreme Committee for Urban Planning, said: "The Resolution issued by the Crown Prince of Dubai to form the Committee supports the vision of HH Sheikh Mohammed bin Rashid Al Maktoum to make Dubai the best city in the world to live in. The Committee will coordinate the efforts of all concerned bodies in Dubai to implement the deliverables of the 2040 Urban Master Plan in line with Dubai's development plan. It will also focus on addressing strategic matters such as housing and regulation of the real estate sector and improving wellbeing and creating opportunities within these and other fields."

"The Committee will work to enhance the government's multi-level framework, endorsed as part of the deliverables of the Dubai Urban Master Plan 2040, to ensure the implementation of infrastructure and urban development projects that support the economy and enhance Dubai's status as the best city to live in. This framework has been developed as per an integrated and comprehensive technical study conducted according to global benchmarks," added Al Tayer.





Latifa bint Mohammed gives green light for governance system and 100-day plan to develop Al Quoz Creative Zone

Dawoud Al Hairi, Director General of Dubai Municipality: His Excellency Sami Al Qamzi, Director General of Dubai Economy; His Excellency Helal Saeed Almarri, and Director General of the Department of Tourism and Commerce Marketing (Dubai Tourism); and Her Excellency Hala Badri, Director General of Dubai Culture, discussed a comprehensive proposal to manage the project, aiming to develop an integrated creative ecosystem for creatives. cultural innovators and entrepreneurs. The Zone will enhance the value of Al Quoz as a regional and global centre for designers and creatives who wish to live, create and work within it and from a professional and lifestyle perspective. The meeting also deliberated on the approval for the project's governance system and its objectives and progress indicators of the 100-day plan to implement its first phase.

Her Highness said: "This is a pioneering project with ambitious goals, and we want it to be the best model for a creative ecosystem locally and globally. We have a

clear vision to accomplish this unique national project in line with the vision of His Highness Sheikh Mohammed bin Rashid Al Maktoum, who continues to inspire us with his leadership and unique forward-thinking philosophy in shaping the future. I have confidence in the outstanding competence of all committee members and their ability to actualise this initiative at the highest standards and to realise His Highness's vision for a future in which Dubai leads the global cultural scene and is the pre-eminent hub for talent and enterprise in the creative economy."

Her Highness Sheikha Latifa approved the governance system for the project, which defines the roles and functions of all project teams. The Executive Team includes Her Excellency Hala Badri. Director-General of Dubai Culture. the Chairperson of the Team; Eng Hussain Al Banna, Executive Director of Traffic Department, Roads and Transport Authority (RTA), the Vice Chairperson of the Team; and representatives from Dubai Culture, RTA, Dubai Municipality, Dubai Economy, and wasl Asset Management Group.





The infrastructure development project team, headed by Eng Hussain Al Banna from RTA, includes representatives of Dubai Municipality, wasl Asset Management Group and Dubai Culture, while the creative community support project team is headed by Lina Zain Al Din from Dubai Culture and includes representatives from Dubai Economy and Dubai Tourism. All these teams are supported by a Dubai Culture team.

Her Highness Sheikha Latifa emphasised the importance of integrating the roles of team members and the need for cooperation and team spirit. Her Highness also approved the 100-day plan, a comprehensive development plan that outlines the priorities for the teams and their goals and project indicators. Priorities for the infrastructure development project team include conducting a comparative study on similar projects that combine living, working and public creative spaces; developing a multiuse space model; submitting recommendations to the project committee; and identifying activities related to the creative industries sector and necessary permits in the Al Quoz Creative Zone.

His Excellency Mattar Mohammed Al Tayer, Director General, Chairman of the Board of Directors of the Roads and Transportation Authority and Vice Chairman of the Al Ouoz Creative Zone Committee, said: "The approval of the governance system for the project and the progress indicators of the 100-day plan marks the completion of a key stage in transforming the Al Quoz Creative Zone into an integrated centre that attracts innovative and creative individuals from around the world. The initiative will create an artistic and cultural destination for tourists. RTA supports the Al Quoz Creative Zone with a series of projects focused on facilitating the movement of residents and visitors to the area. It includes the redesign of roads and pathways in the area by developing an infrastructure to integrate various means of transportation and flexible mobility in Al Quoz and connecting the zone with the Al Safa metro station, the construction of common paths for pedestrians, bicycles and e-scooters, the implementation of a bridge designed creatively for pedestrians, bicycles and scooters on Al Manara Street, and the development of a bus route between Al Safa Metro station and the area's tourist and artistic attractions such as restaurants, shops and outdoor exhibitions. RTA will add aesthetic and innovative features across various facilities and transportation means in the Zone in alignment with the project's brand identity."

His Excellency Dawoud Al Hajri, Director General of Dubai Municipality, said: "Dubai continues its march towards



consolidating its position as a destination and hub for the creative economy in line with the directives of His Highness Sheikh Mohammed bin Rashid Al Maktoum. Vice President and Prime Minister of the UAE and Ruler of Dubai.

His Excellency Sami Al Qamzi, Director General of Dubai Economy, said: "We look forward to moving forward with the implementation of the Al Quoz Creative Zone in an optimal manner that would befit Dubai's leading position and role in the cultural sector regionally and globally, in line with the directives of our wise leadership.

His Excellency, Helal Saeed Almarri, Director General of the Department of Tourism and Commerce Marketing (Dubai Tourism), commented: "With Dubai taking the lead globally in restarting various sectors, a key focus now is to accelerate the momentum of recovery through strategic initiatives like the Al Quoz Creative Zone, based on the vision of His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice President and Prime Minister of the UAE and Ruler of Dubai, to make the emirate the global capital of the creative economy by 2025

Her Excellency Hala Badri, Director General of Dubai Culture, commented: "The development of the project's governance system and the elements of its comprehensive 100-day plan came as a result of the joint efforts of Dubai Culture and the members of the Al Ouoz Creative Zone Committee.

His Excellency Hesham Al Oassim. CEO of wasl Asset Management Group, said: "Our mandate is to help realise the vision of His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice President and Prime Minister of the UAE and Ruler of Dubai, to make the emirate the ideal place to work, live and visit. Priorities for the infrastructure team include providing flexible mobility, launching the visitor transportation service from Al Safa Metro Station to the Al Quoz Creative Zone, developing the initial design for pedestrian routes and individual transportation means and providing advisory services (study and design) for transportation integration and flexible mobility in the Zone, in addition to renaming the streets in the area and encouraging landowners there to provide units for creatives.

Priorities for supporting the creatives include activating cultural visas for creatives in Al Quoz, launching a dedicated platform for them within 'Invest in Dubai', offering a membership programme called "Al Quoz Creative Membership", and developing an integrated marketing strategy to attract talent and spread awareness locally and globally about the Zone.

RTA, Dubai Police discuss operation of E-Scooter, Moped and Streetlighting

The two bodies review traffic safety strategy implementation indicators

His Excellency Mattar Mohammed Al Tayer, Director-General, Chairman of the Board of Executive Directors of the Roads and Transport Authority (RTA), and His Excellency Lieutenant General Abdullah Khalifa Al Marri, Commander-in-Chief of Dubai Police, held a coordinative meeting to discuss issues of common concern. Discussions covered coordination between the two parties in the fields of transport security, traffic safety and the achievement of the strategic performance indicators along with the targets of the Dubai Traffic Safety Strategy 2017 - 2021.

The meeting, which took place at RTA's Head Office, had discussed the latest developments related to the proposed regulatory model for operating E-Scooters, and Moped together with RTA's street lighting plan in various Dubai districts 2022 - 2025.

At the outset of the meeting, Al Tayer welcomed His Excellency Lieutenant General Abdullah Khalifa Al Marri and praised the strategic partnership between the RTA and

Dubai Police. He also hailed the contribution of coordinative meetings to leveraging the cooperation and realising the objectives of the Dubai Traffic Safety Strategy i.e. reducing traffic incidents. They also examined the security and safety strategy aboard transit means in the interest of citizens, residents and visitors of Dubai.

His Excellency Lieutenant General Abdullah Khalifa Al Marri praised the strategic relationship between the

General HO of Dubai Police and RTA aimed at achieving Dubai's ambitions to deliver excellent delivering pioneering services and solutions at the highest global standards in the fields of roads, transport and related security. He stressed that such coordinative meetings between the two entities aimed to step up the level of cooperation and work in a team spirit towards bringing happiness to people and boosting the public security and traffic safety in the Emirate.

E-Scooter

The meeting reviewed the results of the trial operation of the E-Scooter rolled out in October 2020. Currently, there are about 800 E-Scooters in operation within five kev Dubai districts namely: The Mohammed bin Rashid Boulevard, Jumeirah Lakes, Dubai Internet City, Al Riqqa & Al Muraggabat, and the 2nd of December Street (designated lanes and range). It was reported that the experimental deployment of E-Scooters proved successful and befitting to short-journey individual mobility as well as the first and last-mile journeys. The satisfaction rating of the experiment reached 82%.

The meeting discussed preparations for the permanent operation of E-Scooters across the Emirate upon the completion of the trials. Aspects reviewed included selecting the best model that suits Dubai and benefiting from the deliverables of the trial run phase as well as the expertise of major cities in this regard. The meeting discussed benchmark of operating of E-Scooters in a host of metropolitan cities like London, Paris, New York, Berlin and Singapore. The study highlighted the different objectives underlying the operation of E-Scooters in those cities such as easing congestion or providing new mobility means.

Discussions also covered the preparedness of the infrastructure and the public awareness of this new mobility means. Attendees looked into the key elements of regulating the operation of the shared and personalised E-Scooter to be introduced shortly. Discussions focused on four key elements: the user, the E-Scooter, the road. and the commercial model to be provided by operators. The meeting also discussed the districts proposed for the upcoming trial run in October 2021.

Streetlighting

The two parties discussed RTA's street-lighting plan for 2022 - 2025 in several areas of Dubai. The plan envisages carrying out yearly street-lighting works in 45 districts across the Emirate. It covers lighting streets extending 97 km in 12 districts in 2022, 105 km in 15 districts in 2023, 100 km in 13 districts in 2024, and 85 km in 5 districts in 2025.

Moped

The meeting examined a proposal to regulate the operation of the lightweight pedalled motorbike known as Moped. It is fitted with two or three wheels powered by a motor designed to travel at a speed not exceeding 50 km/h. It differs from the regular motorbike in terms of engine power and speed. Some cosmopolitan cities started to license mopeds as a first and last-mile mobility option but under specific conditions and within certain areas to ensure the safety of riders and road users.

The meeting reviewed the benchmarks related to the conditions and controls governing the use of mopeds in advanced countries such as the USA, Spain, Italy and France. The discussion also covered the proposed regulation to govern the use of moped in Dubai including the age of the user, permitted streets, maximum engine power, registration & licensing, and the maximum speed among others.

Maitha bin Adai, CEO of Traffic and Roads Agency, Ahmed Hashim Bahrozyan, CEO of Public Transport Agency, Abdulla Yousef Al Ali, CEO of Licensing Agency, Nasir Bu Shehab, CEO of Strategy and Corporate Governance Sector, Moaza Al Marri, Executive Director, Office of RTA Director-General, Chairman of the Board of Executive Directors, Husain Al Banna, Executive Director of Traffic, and Eng. Nabeel Mohammed Saleh, Director of Roads. From the Dubai Police attended Brigadier Saif Muhair Al Mazrouei, Director Of the General Department of Traffic, Jamal Salem Al Jallaf, Director of Criminal Investigation Department (CID), and Colonel Adel Al Joker, Assistant Director of the General Department of Investigations for Research and Investigation Affairs.

RTA awards contract for constructing internal roads stretching 34.4 km in 3 residential areas

The project is undertaken in response to the directives of Mohammed bin Rashid and Hamdan bin Mohammed

Dubai's Roads and Transport Authority (RTA) has awarded a contract for constructing internal roads project at three residential communities namely Al Quoz 2, Nad Al Sheba 2 and Al Barsha South 3. The network, which spans 34.4 km in length, is expected to be completed in the second half of 2022. RTA is undertaking this project in response to the directives of His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice-President, Prime Minister of the UAE, Ruler of Dubai, and the orders of His Highness Sheikh Hamdan bin Mohammed bin Rashid Al Maktoum, Dubai Crown Prince, Chairman of the Executive Council. Such directives call for improving the infrastructure of residential areas to cope with the demographic and urban growth of residential areas, uplift the living standard and increase the happiness of residents.

Al Quoz 2

"Undertaking the internal roads project translates the commitment of the RTA to improve the infrastructure of roads, streetlights, and rainwater drainage systems in residential areas. The internal roads project at Al Quoz 2 covers the construction of an internal roads network extending 16 km in an area situated between Al Khail and Al Meydan Roads. The scope of the project also includes infrastructure works such as rainwater drainage and streetlights," explained His Excellency Mattar Mohammed Al Tayer, Director-General, Chairman of the Board of Executive Directors of the Roads and Transport Authority.

Nad Al Sheba 2

"The internal roads network at Nad Al Sheba 2 covers the construction of roads extending 12 km along with parallel parking and streetlights besides linking with the stormwater and sewage networks. An assessment will be carried out to the existing internal roads extending 27 km from engineering, traffic safety and rainwater drainage perspectives. Nad Al Sheba 2 is a residential area bordering three main roads namely, The Dubai – Al

Al Tayer: The project serves Al Quoz 2, Nad Al Sheba 2 and Al Barsha South 3 communities

Ain Road westwards, Nad Al Hamar Street eastwards and southwards, and Al Manama Street northwards. The project will enhance the efficiency of the traffic flow and traffic safety in the area by improving the entry/exit points, paving streets that serve all residential plots in the area in addition to providing two new entry/exit points from and to Al Manama and Nad Al Hamar Streets to improve the link with the surrounding areas," commented RTA's Director-General. Chairman of the Board of Executive Directors.

Al Barsha South 3


"Internal roads to be paved at Al Barsha South 3 extend 6.4 km within the Mohammed bin Rashid Gardens. The area is surrounded by Al Barsha South northwards, Al Hebiah 1 and 4 southwards (Motor City and Sports City), Arjan eastwards, and Al Barsha South 4 westwards. The project works include streetlights, car parks and a bus station. The project will provide access to the recently developed land plots at Al Barsha South 3," added Al Tayer.

Al Khawaneej 2

It is noteworthy that RTA is currently undertaking internal roads extending 77 km comprising of 68 km of single carriageways and 9 km of collector dual carriageways at Al Khawaneej 2. The contractor is working on the final touches of the project.

Last year, RTA accomplished Sama Al Jaddaf and Oud Al Mateena 1 Internal Roads Construction Projects. Sama Al Jaddaf Project covered constructing roads extending 12 km and linking them with the main surrounding roads

such as Al Khail Road southwards, and Sheikh Rashid Street northwards. RTA also constructed several junctions including two signalised junctions and streetlight works. Oud Al Mateena 1 Internal Roads Project covered the construction of internal roads for the Mohammed bin Rashid Housing Establishment extending 7 km and linking them with the surrounding roads network. The project ensures a smooth and safe entry and exit of roads users to nearby areas. Works also included streetlights, roadside parking and pedestrian pavements.




Integrating transport around 9 Expo 2020 Bus Stations

The project adds 45 km to the cycling tracks

Dubai's Roads and Transport Authority (RTA) has endorsed a project for integrated transport and flexible mobility around 9 Expo 2020 bus stations. RTA shall undertake the project in collaboration with Nakheel, Dubai Silicon Oasis, TECOM, and Dubai Properties.

"The project aims to encourage the use of environmentally friendly alternative transport means such as cycling tracks and encouraging public to use pedestrian walking paths as well as public transport means, such as the metro, tram, marine transport and public buses. It focuses



on improving the surrounding environment as it will promote the integration of multi-modal transit means. Improvements include providing pedestrian pavements and addressing traffic safety requirements such as safe crossings, and traffic signals designated for pedestrians and cyclists. Accordingly, RTA has to ensure noninterrupted cycling tracks, address the mobility needs of people of determination to ease their accessibility to all mobility means in place, maximise the benefit from public and transport, and ensure the integration of public transport means with alternative transport means," said His Excellency Mattar Mohammed Al Tayer, Director-General, Chairman of the Board of Executive Directors of the Roads and Transport Authority.

Flexible Mobility

"The project includes the enhancement and implementation of mobility and connectivity standards around 9 Expo 2020 Bus Stations at Al Baraha, Al Ghubaiba, Al Jafiliya, Business Bay 2, Dubai Silicon Oasis, International City, Palm Jumeirah, Etisalat and the Union Bus Stations. The project will add 45 km to the cycling tracks network, which renders Expo Bus Stations as an excellent model of integrated and environmentally friendly stations. The project concept revolves around improving and configuring the infrastructure to support network flexibility and environment sustainability besides improving the surrounding areas for pedestrians," commented Al Tayer.

"RTA is committed to providing residents-

friendly infrastructure that meets the requirements of integrated transport and serving the integration of the city to ease the access to mass transit stations. It also makes every effort to ensure safe and smooth access of pedestrians and cyclists to those means to nurture a hospitable environment for peoples of determination," he noted.

"In all public transport projects, RTA assigns special attention to improving the link of public transport stations with development projects and the surrounding attraction areas. This entails addressing the first and last-mile needs, providing elements that assist with the integration of transit means, such as bus stops, cycling tracks, pedestrian crossings, rest areas, shaded paths, landscaped areas, parking for rented cars, and bike racks. Providing these elements will encourage people to use non-conventional mobility means like walking and biking and the use of E-Scooters in commuting between their homes and public transport stations," elaborated Al Tayer.

Project Components

"Works of the project provide for an integrated environment around metro and bus stations, which entails constructing 226 pedestrian paths and 857 dropped kerbs, creating paths for people of determination at 1053 points, in addition to the implementation of a host of speed calming measures such as humps, shared cycling & pedestrian tracks, shared cycling & vehicles lanes, roadside parking slots, and wider pedestrian pavements.

Dubai Road Facilities Condition Index clocks 99%: RTA

Dubai's Road Facilities Construction Condition Index has reached 98.95%, which translates the relentless efforts of various teams of the Roads and Transport Authority (RTA) to maximise the benefits and minimise the operational costs of these facilities. The technical assessment of road facilities condition is conducted using the Bridges Maintenance Management System (BMMS). RTA also adopts maintenance strategies compatible with the international asset management standards ISO 55000 and ISO 55001.

"The Traffic and Roads Agency plays a key role in managing RTA's infrastructure assets to protect the deliverables of mega projects undertaken since RTA's inception. It serves RTA's vision to become 'The World Leader In Seamless & Sustainable Mobility' and serve the strategic goal (Asset Management) set in RTA's Strategic Plan 20202040-. Achieving a 98.95%

rating in Dubai's Road Facilities Construction Condition Index is a result of the predictive maintenance programme and the extensive technical assessments undertaken. Such operations covered all elements of road facilities using sophisticated artificial intelligence technologies of the 4th Industrial Revolution. Adopting such a methodology has become a







crucial element of the maintenance and sustainability of Dubai infrastructure assets," said Eng. Maitha bin Adai, CEO of Traffic and Roads Agency, RTA.

"Since RTA's launch of the Bridges Maintenance Management System, which caters to the management of bridges during the asset lifespan, in 2017, the number of inspection and assessment of operations of facilities (bridges, tunnels ... etc) has seen a remarkable increase. About 1522 facilities have been covered by expert assessments including civil and (constructional elements as well as electromechanical systems). The figure constitutes a 10% annual increase in the technical assessments of road facilities," she added.

Maitha called on the public and road users to cooperate with RTA in protecting the superior infrastructure facilities of the Emirate through complying with the speed limits & traffic rules and reporting any damage or comments about the elements and furniture of road facilities. She stressed that such cooperation would ensure compliance with the highest standards of safety and contribute to the happiness of all community members.

Opening 570m long bridge of three lanes on Al Khaleej Street

The bridge serves traffic inbound from Al Mamzar and Deira Islands in the direction of Shindagha Tunnel

Dubai's Roads and Transport Authority (RTA) has opened today (Saturday) the main bridge on Al Khaleej Street extending 570 metres comprising of three lanes in the direction of Bur Dubai as well as a surface junction at the intersection of Al Khaleej Street and Omar bin Al Khattab Street. The opening is part of Shindagha Roads Corridor, one of the biggest road projects currently undertaken by the RTA that extends 13 km from Sheikh Rashid Street and passes through Al Mina Street and Al Khaleej Street up to Cairo Street.

"The bridge can handle 4,800 vehicles per hour. It serves the traffic on Al Khaleej Street inbound from the junction of Abu Baker Al Siddique Street and Deira Islands in the direction of Shindagha Tunnel. Thus, it ensures a smooth flow of traffic along Al Khaleej Street. RTA also opened a surface signalised junction at the intersection of Al Khaleej Street and Omar bin Al Khattab Street," said His Excellency Mattar Mohammed Al Tayer, Director-General, Chairman of the Board of Executive Directors of the Roads and Transport Authority.



The bridge can handle 4,800 vehicles per hour

"Traffic has also been diverted inbound from Al Mamzar. the junction of Abu Baker Al Siddique Street, and Deira Islands to the new bridge, and then to the surface junction at the intersection of Al Khaleei Street and Omar bin Al Khattab Street. The project fulfils all traffic safety stipulations such as street lights, road markings, and directional signage according to the approved designs to ensure top safety levels for road users and pedestrians," explained Al Tayer.

"The completion rate of the current contracts of Shindagha Roads Corridor Project has reached 70%. Due to the massive scope of the project, it had been split into five phases that serve development projects in the areas such as Deira Islands, Dubai Waterfront, Dubai Maritime City and Mina Rashid. It can also accommodate the projected future traffic volumes. Upon completion, the project will cut short the travel

time across Shindagha Corridor from 104 minutes to just 16 minutes.

"RTA had accomplished two phases including upgrading the junction of Sheikh Rashid-Oud Metha Streets (Wafi Junction), and the intersection of Sheikh Rashid-Sheikh Khalifa bin Zayed Streets. Work is currently underway in Phase III, which covers the construction of Shindagha Bridge, improvements of Corniche Street, intersections on Al Khaleej street and Falcon Interchange. Last August, RTA opened bridges leading to the entry/exit points of Deira Islands at Abu Baker Al Siddique Street.

"Phase IV of the Project covers improvements of Al Khaleej Street along with the intersection with Abu Hail Street. It also covers improvements of the intersection of Sheikh Rashid Street with Jumeirah, Al Mina and Al Mankhoul Streets. This Phase is expected to be completed by the end of 2025. Phase V covers the construction of bridges leading to Deira Islands southwards, which is set for completion by 2027.

The results were positive and no negative effects were recorded on the engines as a result of using biofuels. ENOC Group had appointed a specialised company as a neutral party to evaluate the results of the experiment.

"The use of biofuel to power traditional Abras of the private sector operating on Dubai Creek is optional. However, with the discount on the price of biofuels, courtesy of ENOC Group, we expect Abra operators to opt for clean fuel. It is confirmed that RTA would not bear any expenses in this regard," he further added.

Research indicates that the use of biodiesel reduces the

reduction of the PAH gas, a cancer antigen.

There are 148 traditional Abras operated by the private million riders annually (90% of the total number of marine transport riders in Dubai). The existing fleet of traditional Abras uses 30hp diesel engines that consume 1.1 million litres of diesel per annum.

RTA has placed sign boards at the designated parking lots nearby all vaccination centres to make it easy for motorists to recognise those areas for parking their vehicles and directly accessing the vaccination centres.

Public transport services are critical for commuting the staff engaged in the delivery of basic services in the city such as healthcare, emergency, foodstuffs, and logistic services. In this regard and a part of its continues efforts on combating Covid-19, RTA deployed 74 buses on 13 routes serving 19 public and private hospitals to commute riders free of charge during the National Disinfection Programme. It also provided 1000 taxis to offer emergency services during the

RTA shifts part of vehicle licensing services to smart platforms

Dubai's Roads and Transport Authority (RTA) will shift several vehicle licensing certificates and payment of fines services to smart and electronic channels. Accordingly, the processing of these services will cease at customers happiness and service provider centres as of June 13, 2021.

"The processing of 5 vehicle licensing certificates will be transferred to alternative smart and online channels. They include insurance refund certificate (refunding the amount corresponding to the remaining period in the motor insurance policy), vehicle ownership certificate, non-ownership of vehicle certificate, vehicle clearance certificate, and a detailed list of registered vehicles in addition to the payment of fines service," said Jamal

Hashim Al Sadah, Director of Vehicles Licensing, Licensing Agency, RTA.

"Customers can process these certificates via RTA's website (www.rta.ae), Dubai Drive App, Smart Kiosks or the Call Centre (8009090). RTA has a plan to transfer more licensing services to smart and electronic channels this year, such as vehicle possession certificate, and vehicle export certificate.

National Disinfection Programme at half of the applicable fare and deployed 120 drivers to support the medical sector. Launching 5 new bus routes, cancels one and improves others

Dubai's Roads and Transport Authority (RTA) launched 5 new bus routes in Dubai on June 1st, 2021. The step aims to enhance the internal bus network and integration with other mass transit services in the Emirate. On the same date, RTA will also improve 6 other bus routes and cancel one route. The path of the new five routes will be as follows:

Route 14 will start from Oud Metha Bus Station and head to Al Safa Bus Stop at a frequency of 20 minutes during peak times.

Route 23 will start from Oud Metha Bus Station and head to Al Nahda 1 at a frequency of 30 minutes.

Route 26 will start from Oud Metha Bus Station and head to the Business Bay Bus Station 2 at a frequency of 20 minutes during peak time only on weekdays except for Friday.

Route F50, a metro link service, will start from the Dubai Investment Park Metro Station and head to the Dubai Investment Park Complex 2 at a frequency of 30 minutes.

Route F51, also a metro link service, will start from the Dubai Investment Park Metro Station and head to the Dubai Investment Park Complex 1 at a frequency of 20 minutes.



70% rise in marine transport ridership in Q1, 2021

The Roads and Transport Authority reported a 70% increase in the number of marine transport riders during the first quarter of this year, compared to the same period last year. Statistics show that 1,713,399 riders used various types of marine transport means during the first three months of this year, which indicates the speedy recovery from the aftermath of the Covid-19 and the return of normal life indicators.

"RTA seeks to provide public transport network characterised by smooth and integrated multi-modal means to meet the variable needs of people and add to their happiness. RTA's Marine Transport Department is therefore in constant pursuit to promote the integration of mobility means," said al Mohammed Abu Bakr Al Hashmi, Director of Marine Transport, Public Transport Agency, RTA.

"The marine transport services are integral part of RTA's public transport network. RTA developed a Master Plan for Marine Transport in Dubai 20202030-, which defines future stations,







The last two routes will serve the central business districts of both Deira and Bur Dubai. They had been plotted to serve the rising demand as well as the urban and demographic growth in the two neighbourhoods.

Apart from that, on June, 1st 2021, RTA will introduce improvements and extensions to several other bus routes. Route 20 will be extended to serve the Head Office of Fly Dubai at Warsan. Route F09 will be converted into a circular route and will not serve Al Wasl Park. Routes F14, F19A and F19B will be extended to serve the new Business Bay 2 Bus Station. Route X23 will serve the Oud Metha Station during off-peak time, which will improve the travel time during peak times.

On the same date, RTA will improve the timetables of 28 routes, namely: Routes 20, 61D, 66, 91, 91A, 95, CO3, C05, C18, E303, E306, E307, E307A, F03, F09, F14, F19A, F19B, F49, F50, F51, F55, F61, F70, X23, X25, X92, and X94. It will also cancel Route C14. Passengers using this service are recommended to use the two alternative routes 14 and 23.

RTA renews its commitment to expanding the coverage of the public bus network and improving its integration with other mass transit means, such as the metro, tram and marine transport. Improving the link between mass transit modes will render them the ideal choice for mobility across the Emirate.

modes and lines based on the Urban Plan of the Emirate and the projected demographic growth. Under the plan, RTA intends to extend the marine transport network by as much as 188% to reach 158 km, and quadruple the number of passenger transport lines by 400% to reach 35 lines offering scheduled passenger services," he commented.

"RTA is undertaking experiments to switch to clean energy power 8-passenger abras with solar power and trialled the use of a hybrid abra that can carry up to 20 passengers. The aim was to carbon footprint associated with the operation of fuel-powered marine transport means. RTA also rolled out the test run of 5 traditional abras powered by biofuel (Biodiesel 5), which is officially approved in the UAE. The experiment, which was coordinated with ENOC Group, revealed very positive results,"

- The Marine Transport Plan envisages increasing the marine transport fleet by 32% to reach 258 marine transport means, and the number of stations by 65% to reach 79 stations up to 2030.
- RTA currently has 56 marine transport means, and oversees the operation of 148 traditional abras.

Realising this objective requires developing advanced futuristic transport systems and improving the sustainable transport network in Dubai to encourage people and visitors to use public transport," said Abdul Mohsen Ibrahim Younes.

"RTA is aligning its efforts with the national agenda to nurture a sustainable environment in terms of air quality and reliance on clean energy. 2019 Novel Coronavirus (COVID-19)

On 30 January 2020, World Health Organization (WHO) declared the outbreak of the novel coronavirus (nCoV or COVID-19), which emerged in China and spread to several countries across the globe causing a global health emergency.

If you notice these symptoms or some of them, contact the health facilities, which are available in the UAE, to request diagnosis and assistance, and to avoid mixing with others.

The UAE Government Portal released several tips and guidelines, as shown here, to protect against the pandemic, and how to cope with it when the person takes the disease. Symptoms depend on the type of virus, from the "Corona" family, but the most common are respiratory symptoms, fever, shortness of breath, difficulty breathing, and in the most severe cases: pneumonia and acute respiratory syndrome.

Tips to stay safe from COVID-19

Maintain a physical distance of 2 metres (6 feet) from others. Wash your hands regularly for at least 20 seconds

What to do?

- Take a vaccine to protect yourself from COVID-19, unless there is a medical contraindication.
- Download the Emirati Al-Hosn app to track contacts of the COVID-19 virus.
- ■Adhere to the rules of spatial distancing, and maintain a distance of at least two metres: (6 feet) from others.
- ■Wash your hands with soap and water, for at least two minutes, and use an alcohol-based hand sanitiser, if possible.
- ■Wear a mask and gloves when you go out.













and sanitise them often. Wear simple masks and gloves when stepping out. Learn how to wear a mask safely. Avoid greeting people by shaking their hands or hugging or kissing them. Don't touch your face; particularly your eyes, nose and mouth. Follow healthy behaviour when coughing or sneezing.

Comply with the health preventive measures, such as:

- ■Don't touch objects or surfaces in public areas
- Carry out daily cleaning and sterilisation of various surfaces at home and workplace, including doors, handles, tables, toilets, computers, keys and office stationery.
- Follow COVID-19 precautions in your workplace and public places.
- Take information from official sources, and have confidence in the UAE, which follows the highest standards of health care to combat COVID-19.
- ■Follow the instructions of the concerned authorities, regarding precautionary and preventive measures, to limit the spread of the virus.
- Pay attention to your health symptoms, and if you feel unwell, stay home, and contact your local health authority for guidance.



What to avoid?

- Handshakes, kisses and hugs.
- ■Touching your face, especially your eyes, nose and mouth, to prevent the virus from entering your body.
- ■Exceeding the allowed number of passengers per car, which is three people.
- **■**Spreading rumours.

Aldar building

Located in the UAE capital, Abu Dhabi, Aldar Building is the first circular building in the Arabian Peninsula. The building won the title of best modern design at the Building Exchange Conference, which was held in Spain in 2008. In addition to its engineering design, the building has a combination of high international standards of construction and contemporary Islamic designs.





National Center for the Performing Arts
