<b>Activity Description</b>	Establishments that rent two or more wheeled bikes that are not equipped with an engine. Such bikes are driven by the force of the rider and used for transportation, hiking or sporting in designated locations.

<b>Conditions and Procedures of Issuing the Permit</b>	<ol style="list-style-type: none"> <li>To issue the permit, the applicant shall obtain the initial approval of the licensing authority.</li> <li>The owner of the establishment, or his legal representative, submits the permit application prepared by the RTA through its approved service delivery channels, accompanied by the following documents: <ol style="list-style-type: none"> <li>The initial approval to conduct the activity issued by the licensing authority in the Emirate for new establishments, and a copy of the commercial license for existing establishments.</li> <li>The approval of the competent authority to carry out the activity if the legislation in force requires obtaining such approval.</li> <li>A copy of the valid passport or identity card of the establishment's owner and all partners, in addition to a copy of the valid residency voucher for the non-citizen partner.</li> <li>An undertaking to abide by the conditions and requirements necessary to carry out the activity.</li> </ol> </li> </ol>		
<b>Responsibilities of the Entity</b>	<p><b>First: Responsibilities of the Entity:</b></p> <ol style="list-style-type: none"> <li>Comply with the regulations, resolutions and instructions of the RTA regarding the activity.</li> <li>Provide bikes with specifications befitting the activity as decided by the Agency or the concerned entities in this regard.</li> <li>Carry out the activity specified in the permit.</li> <li>Not to assign the permit to a third party or dispose of it in any way, except after obtaining the prior approval of the Agency.</li> <li>Use the parking spaces approved by the RTA and concerned bodies in the Emirate when practicing the activity.</li> <li>Cooperate with RTA officials and those authorized by the RTA, and provide the Agency with the required information and documents.</li> <li>Obtain licenses and permits required by the legislation in force in the Emirate.</li> <li>Not to stop practicing the activity without obtaining the prior approval of the Agency. This approval shall be issued in accordance with the conditions and procedures adopted by the Agency in this regard.</li> <li>Keep records that include all data related to the practice of the activity for the periods specified by the Agency in this regard.</li> <li>Obtain the approval of the Agency in case of changing the location of the establishment.</li> <li>Use bikes for authorized use only and in compliance with the activity stated in the permit.</li> <li>Fulfill the security and safety stipulations set by the concerned body.</li> <li>Provide cycling gear (phosphorus clothing).</li> <li>Refrain from cycling in prohibited areas.</li> <li>Provide a shockproof cycling helmet in multiple sizes.</li> <li>Refrain from renting the bike without the protective helmet.</li> <li>Refrain from renting the bike to anyone under 16 years of age. and the size of the bike shall be commensurate with the size of its rider.</li> <li>Allocate bikes parking spaces, and refrain from damaging public parking or right-of-way, or parking bikes on pedestrian walkways, <b>(if any)</b></li> <li>Use cycling lanes specified by the RTA.</li> </ol>		

- 20- Refrain from installing any electrical or mechanical device that transforms it into an electric or motorcycle.
- 21- Obtain the approval of RTA regarding the location of practicing the activity.
- 22- Agree to undertake to comply with the additional requirements set by the Agency.

**Second: Technical requirements for bikes: -**

- 23- Front main white lamp, and rear red lamp
- 24- Red reflector at the back.
- 25- Horn fixed on the steering wheel.
- 26- Brakes on the front and rear tires.
- 27- There is a proportionality between the tire sizes and the bike size.
- 28- Road- and track-appropriate tires.
- 29- Any other conditions set by the RTA.
