	D. An undertaking to abide by the conditions and requirements necessary to carry out the activity.

	1- Comply with the regulations, resolutions and instructions of the RTA regarding the activity.	
	2- Not to assign the permit to a third party or dispose of it in any way, except after obtaining the prior approval of the Agency.	
	3- Provide an office, vehicles and parking spaces commensurate with the nature of the activity authorized to be practiced, and comply	
	with the controls and standards approved by the Agency in this regard.	
	 4- Carry out the activity specified in the permit. 5- The vehicle designated to carry out the authorized activity shall be registered in the Emirate of Dubai, whether it is owned or 	
	leased by the establishment.	
	6- Use the vehicle for authorized use only.	
	7- Comply with the times and places when and where the practice of the activity is prohibited as determined by the competent

Entity	8- Install a tracking system, a speed limit system, or other systems specified by RTA or the concerned entity. (if any)	
	9- Use the parking spaces approved by the RTA and concerned bodies in the Emirate when practicing the activity.	
	10- The vehicles in which the activity is carried out shall be inspected when licensing or renewing its license at the service centers	
	specified by the Agency in this regard. 11- Adhere to the terms and conditions of the approved technical examination determined by the Agency.	
	12- Cooperate with RTA officials and those authorized by the RTA, and provide the Agency with the required information and	
	documents.	
	13- Obtain licenses and permits required by the legislation in force in the Emirate.	
	14- Not to stop practicing the activity without obtaining the prior approval of the Agency. This approval shall be issued in accordance	
	with the conditions and procedures adopted by the Agency in this regard.	
	15- Keep records that include all data related to the practice of the activity for the periods specified by the Agency in this regard.	
	16- Obtain the approval of the Agency in case of changing the location of the establishment.	
	17- Refrain from pasting or carrying any promotional material on the body of the vehicle before obtaining prior approval from the RTA	
	18- Fulfill the security and safety stipulations set by the concerned body.	





	19- The applicant is committed to providing the systems, electronic media and smart applications necessary to practice the activity and
	link them with RTA's systems such as: (Quality violations code, control systems, data provision, payment of fees as part of agreements
	concluded with the RTA, installation of tracking devices, etc).
	20- In the event of renting the transport means from another party or contracting with another party to undertake the delivery service,
	then that party shall be licensed for this purpose by the RTA.
	21- Contracting with companies licensed by the RTA according to the types of transport and delivery activities.
	22- Sign an agreement with the RTA.
	23- Agree to undertake to comply with the additional requirements set by the Agency.
