| Conditions and Procedures of Issuing the Permit | <ol style="list-style-type: none"> 1. An applicant for a permit for the activity of trading vehicle numbers in the Emirate of Dubai is required to have a traffic file in the Emirate of Dubai. 2. An applicant for a vehicle number trading activity permit must obtain an initial approval from the Roads and Transport Authority. 3. A copy of the identity card and a copy of a valid business activity license issued by the Department of Economic Development are required to obtain the permit. 4. An applicant for a license to trade vehicle numbers in the Emirate of Dubai must deposit a permanent guarantee of 25,000 thousand dirhams. 5. The permit is issued for a period of one year and is renewable for a similar period. 6. When renewing the annual permit for trading numbers, it is required that 15 numbers be provided in the traffic file of trading numbers of the trader. | | |
| Advantages of Authorized Number Traders | <ol style="list-style-type: none"> 1. Transferring the ownership of the numbers available in the trader's traffic file via the website. 2. The trader is granted the authority to print an ownership certificate for the second party through the website. 3. Package auctions for authorized number traders. 4. The new number trader does not have to provide numbers in the traffic file to activate the number trade permit. 5. Exemption from financial guarantees for participation in public and electronic auctions and package auctions. 6. Giving them priority to purchase packages of daily exchange numbers (five-digit numbers that are disbursed upon vehicle registration) from the next code, which has not been launched to the public. 7. Promoting traders through the Authority's website by placing their names and methods of communication with them. 8. Giving traders priority to purchase numbers when launching discount initiatives on some special numbers in the future. 9. Extending the payment period for numbers purchased from public and electronic auctions. | | |
| Licensing Conditions and Entity's Obligations | <p>The authorized person must comply with the conditions and requirements approved by the Authority regarding the exercise of the activity, and he is prohibited from performing any of the following actions:</p> <ol style="list-style-type: none"> 1. Practicing activities other than the authorized activity within the service centers of the Authority. 2. Cessation or disruption of practicing the activity for a period of more than six months without notifying the Authority of that. 3. Organizing auctions on vehicle numbers without obtaining the prior approval of the Authority. 4. Enabling others to use the permit without obtaining the prior approval of the Authority. 5. Selling the same vehicle number to more than one person. 6. Announcing the activity in the service centers of the Authority without obtaining its prior approval. 7. Disrupting or obstructing the work of the Authority's employees. | | |
