<b>Activity Description</b>	Facilities that transport exceptional, explosive or inflammable materials, whether liquid, solid, gaseous, or pressurized, such as explosives or gas cylinders, and it also includes the transport of acidic, radioactive, toxic and oxidizing hazardous materials.

<b>Conditions and Procedures for Issuing the Permit</b>	<ol style="list-style-type: none"> <li>1- The applicant for the permit must be a citizen of the state, or a citizen of the countries of the Cooperation Council for the Arab States of the Gulf, or a legal person who is one of the partners in it who is a citizen of the state.</li> <li>2- For free zones, a legal person or partners' information (non-citizen citizens) in addition to the director's data, based on the free zone requirements.</li> <li>3- It is necessary to obtain the approval of the Supreme Council of Energy before issuing or renewing the commercial license or when updating the license data to practice the activity.</li> <li>4- The permit applicant or his legal representative submits the application to the licensing institution through the service delivery channels approved by the authority accompanied by the following documents: <ul style="list-style-type: none"> <li>A- The initial approval to conduct the activity issued by the commercial licensing authorities in the emirate for new establishments, and a copy of the commercial license for existing establishments. (If any)</li> <li>B- A copy of the valid passport of the owner and all partners, in addition to a copy of the valid residency voucher for the non-citizen partner.</li> <li>C- A copy of the identity card of the owner and all partners.</li> </ul> </li> </ol>		
<b>License requirements And the obligations of the facility</b>	<p><b>General requirements:</b></p> <ol style="list-style-type: none"> <li>1. The firm's commitment, in the event of any change to the trade license, to obtain the necessary approval from the establishment.</li> <li>2. Use vehicles with specifications commensurate with the type of activity and adhere to security and safety measures in accordance with what the institution or the competent authorities specify in this regard</li> <li>3. Commitment to the vehicle manufacturing year and replacement as determined by the institution or the competent authorities in this regard. (If any)</li> <li>4. Renting vehicles owned or affiliated with them to others with prior approval from the competent authority.</li> <li>5. Use the vehicles for the authorized purposes only and adhere to the activity specified in the permit.</li> <li>6. If any promotional materials are affixed or hung on the vehicle's chassis, the prior approval of the Corporation must be obtained.</li> <li>7. Abide by the regulations, decisions and instructions issued by the Authority.</li> </ol>		

**Special requirements:**

1. Placing a distinctive sign on the sides and back of the vehicle stating that its content is flammable and explosive materials and according to international standards for stickers related to hazardous materials.
2. Equipping the vehicle with a tank that can be closed to ensure that the transported materials do not leak.
3. Not to fill in all types of fuel at the companies' headquarters or in public places or truck stops without the approval of the competent authority.
4. Fulfill the requirements of the facility that houses tankers of petroleum products, which are imposed by the competent authority.
5. Satisfy the requirements of the Committee for the circulation of petroleum products at the level of the Emirate
