<b>Conditions and Procedures for Permit Issuance</b>	<ol style="list-style-type: none"> <li>To issue the permit, the applicant shall obtain the initial approval of the licensing authority in the Emirate, in accordance with prevailing regulations in this regard.</li> <li>The owner of the establishment, or his legal representative, submits the permit application prepared by the Authority for this purpose, through its approved service channels, along with the following documents: <ol style="list-style-type: none"> <li>The initial approval to conduct the Activity issued by the Licensing Authority in the Emirate for new Establishments, or a copy of the valid commercial license for existing Establishments.</li> <li>The approval from the Competent Authority to carry out the Activity if the legislation in force requires obtaining such approval.</li> <li>A copy of the valid passport of the establishment's owner and all partners, in addition to a copy of the valid residency voucher for the non-citizen partner.</li> <li>An undertaking to abide by the conditions and requirements necessary to carry out the Activity.</li> </ol> </li> </ol>		
<b>Licensing Conditions and Entity's Obligations</b>	<ol style="list-style-type: none"> <li>Obtain the required Permits from the concerned government bodies in the Emirate and fulfill their requirements.</li> <li>In case of any changes to the trade license, the establishment is obligated to seek the necessary approval from the Agency.</li> <li>Provide vehicles with specifications befitting the Activity as decided by the Public Transport Agency or the concerned entities in this regard.</li> <li>Register vehicles suitable for the Activity after completing the requirements of the vehicle technical inspection.</li> <li>Carry annual testing and renewal of the Vehicle, and comply with the technical testing conditions and standards set by the Agency.</li> <li>Comply with the times and places where the Activity is prohibited, as required by the Competent Authority.</li> <li>Refrain from renting owned or affiliated Vehicles to third parties.</li> <li>Use Vehicles for authorized use only, and comply with the Activity stated in the Permit.</li> <li>Fulfill the security and safety stipulations set by the Competent Authority.</li> <li>Comply with the additional conditions that may be issued by the Agency in the future.</li> <li>Refrain from pasting or carrying any promotional material on the body of the vehicle before obtaining prior approval from the Agency.</li> <li>Use the parking spaces approved by the RTA and the Entity Authorities in the Emirate when practicing the Activity.</li> <li>Cooperate with RTA officials and those authorized by the RTA, and provide the Agency with the required information and documents.</li> <li>Adhere to the technical conditions of the vehicle, which are determined by the Public Transport Agency.</li> <li>Signing a contract with the Authority according to what it determines in this regard:</li> <li>Comply with the regulations, resolutions, and instructions of the Authority.</li> </ol>
