Provide an office, vehicles and parking spaces commensurate with the nature of the activity authorized to be practiced, and comply with the controls and standards approved by the Agency in this regard. Carry out the activity specified in the permit. The vehicle designated to carry out the authorized activity shall be registered in the Emirate of Dubai, whether it is owned or leased by the establishment. Write the name of the facility, and the weight of the vehicle in its empty and loaded condition in a clear and legible way on the external structure of the vehicle, as approved by the Agency in this regard. Refrain from pasting or carrying any promotional material on the body of the vehicle before obtaining prior approval from the RTA. Not to assign the permit to a third party or dispose of it in any way, except after obtaining the prior approval of the Agency. Use the parking spaces approved by the RTA and concerned bodies in the Emirate when practicing the activity. Cooperate with RTA officials and those authorized by the RTA, and provide the Agency with the required information and documents. Install a tracking system, a speed limit system, or other systems specified by RTA or the concerned entity, as per the nature of the activity. Comply with the technical requirements of the vehicle, approved by the Agency and the competent government authorities, according to the activity suborized to be practiced.
