Conditions and Procedures of Issuing the Permit	<ol style="list-style-type: none"> To issue the permit, the applicant shall obtain the initial approval of the licensing authority in the Emirate, in accordance with the legislation in force in this regard At least twenty recreational motorcycles shall be provided for each age group. The period of using the land allocated as an entertainment arena shall not be less than five years. The area of the recreational arena shall not be less than (83,400) square meters, and its design shall be for recreational use only. The owner of the establishment, or his legal representative, submits the permit application prepared by the RTA through its approved service delivery channels, accompanied by the following documents: <ol style="list-style-type: none"> The initial approval to conduct the activity issued by the licensing authority in the Emirate for new establishments, and a copy of the commercial license for existing establishments. The approval of the competent authority to carry out the activity if the legislation in force requires obtaining such approval. A copy of the valid passport or identity card of the establishment's owner and all partners, in addition to a copy of the valid residency voucher for the non-citizen partner. An undertaking to abide by the conditions and requirements necessary to carry out the activity. 		
Obligations of Practicing the Activity:	<ol style="list-style-type: none"> The recreational motorcycle used inside the recreational circuit shall be licensed. The lane for the use of the recreational motorcycle inside the recreational circuit shall be in one direction. The use of safety barriers on both sides of the track, provided that these barriers do not obscure the view, and that they are sufficiently high to prevent the recreational motorcycle from going over them. 		

4. The artificial hills inside the recreational circuit shall not be so steep to be dangerous for the rider of the recreational motorcyclist.
5. The turns inside the recreational circuit should not be sharp to be dangerous for the rider of the recreational motorcycle.
6. Provide the necessary protective, safety and first aid devices and equipment for recreational motorcycle users, in accordance with the regulations and standards approved by the Agency in this regard.
7. Appoint qualified persons to monitor the entertainment circuit, in accordance with the regulations and standards approved by the Agency in this regard.
8. Classify the recreational circuit according to its uses, the engine capacity of the recreational motorcycle used inside it, and the age and gender of its users.
9. Provide the recreational circuit with the necessary guiding and warning signs.
10. Not to make any change in the recreational circuit that may affect the safety and security of the recreational motorcycle rider, except after obtaining the prior approval of the Agency.
11. Determine the dimensions and tracks of the recreational circuit, and set necessary safety barriers.
12. Notify the concerned bodies, including Dubai Police, in the event of any accident occurring inside the entertainment circuit resulting in bodily injuries.
13. Observe the requirements approved by the municipality regarding the natural environment and wildlife in the Emirate.
14. Place a layout at the entrances to the recreational circuit.
15. Not to make any modifications to the recreational motorcycle for the purpose of increasing its speed or the sound of its engine, or to the specifications specified by the Agency.
16. Agree to undertake to comply with the additional requirements set by the Agency.
