<b>Activity Description</b>	Training and qualifying drivers holding driving licenses, with the aim of imparting them with professional driving skills of vehicles such as taxis, light and heavy passenger-transport buses, heavy vehicles for transporting goods, construction vehicles at site and trailers. It is practiced as an additional activity within licensed driving schools <b>only</b> .

<b>Conditions and Procedures of Issuing Permit</b>	<ul style="list-style-type: none"> <li>a) The applicant must be a licensed driving school in the Emirate.</li> <li>b) Initial approval to practice the activity issued by the Licensing Agency.</li> <li>c) Obtain professional permits approved by the concerned governmental bodies if they provide qualification services for specific types of professional driving such as permits for taxis, limousines, and public, private, school and tourist buses.</li> <li>d) Pay the required fees.</li> </ul>		
<b>Licensing Conditions and Entity's Obligations</b>	<ul style="list-style-type: none"> <li>1- Provide an appropriate environment for theoretical training lessons in the entity's HQs in terms of lecture halls equipped with modern means of presentation capabilities suitable to trainees.</li> <li>2- Prepare a specialist training module for professional driving approved by the RTA.</li> <li>3- Provide the department with an annual record of training operations, number of trainees and the contracted companies.</li> <li>4- Provide enough vehicles in different categories equipped according to technical stipulations approved by the RTA and carry out periodic maintenance as well as providing comprehensive insurance.</li> </ul>
